

STATE ROAD 7 IMPROVEMENTS PROJECT IN BROWARD COUNTY AND PALM BEACH COUNTY



SR 7 from Commercial Boulevard to Broward / Palm Beach County Line in Tamarac, North Lauderdale, Fort Lauderdale, Margate, Coral Springs, Coconut Creek and Parkland

Timeline

Cost

\$13,403,577.42

Improvements

- Removing old asphalt and resurfacing the roadway
- Upgrading pedestrian features including 10-foot sidewalks on both sides and detectable warning surfaces at crosswalks
- Installing overhead sign structures
- Upgrading signs and pavement markings to include a 7-foot bike lane in each direction
- Installing new bus shelters with bicycle racks, trash receptacles, and benches
- Upgrading drainage structures
- Upgrading signalization, including pedestrian signals and detectors and vehicle video detection
- Upgrading lighting

Traffic Impact

- One lane in each direction may be closed nightly between 9 p.m. and 6 a.m.
- Two lanes in each direction may be closed nightly between 11 p.m. and 6 a.m.

Improvements

- Removing old asphalt and resurfacing the roadway
- Minor shoulder widening
- Upgrading drainage structures
- Upgrading pedestrian features including a 10foot sidewalk on the west side, a 5-foot sidewalk on the east side, and detectable warning surfaces at crosswalks
- Upgrading signalization, including pedestrian signals and detectors and vehicle video detection
- Upgrading signs and pavement markings to include a 7-foot bike lane in each direction
- Upgrading lighting

Traffic Impact

- One lane in each direction may be closed nightly between 8 p.m. and 7 a.m.
- Two lanes in each direction may be closed nightly between 11 p.m. and 6 a.m.
