## **ORDINANCE NO. 2018-124**

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA, PURSUANT TO SECTION 166.041, FLORIDA STATUTES, TO AMEND ORDINANCE 2017-112, FINALIZING AND ADOPTING THE ANNUAL OPERATING BUDGET AND CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEAR 2017-2018, BY AMENDING EXHIBIT "A", THE ANNUAL OPERATING BUDGET; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with the City Charter and all the laws of the State of Florida,, the City Commission of the City of Coral Springs finalized and adopted budgets for fiscal year 2017-2018 for the General Fund and Fire Fund, as adopted by Ordinance 2017-112 on September 27, 2017; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA:

- **Section 1.** Each and all of the foregoing "Whereas" clauses are true and correct and are incorporated herein.
- Section 2. That the Annual Operating Budget, approved by the City Commission on September 27, 2017, is amended as designated in Exhibit "A" attached hereto.
- Section 3. The City Commission hereby ratifies and confirms all other provisions of Ordinance 2017-112.
