

**ORDINANCE NO. 2019-118**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA, PURSUANT TO SECTION 166.041, FLORIDA STATUTES, TO AMEND ORDINANCE 2018-117, FINALIZING AND ADOPTING THE ANNUAL OPERATING BUDGET AND CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEAR 2018-2019, BY AMENDING EXHIBIT “A”, THE ANNUAL OPERATING BUDGET; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, in accordance with the City Charter and all the laws of the State of Florida, the City Commission of the City of Coral Springs finalized and adopted budgets for fiscal year 2018-2019 for the General Fund and Fire Fund, as adopted by Ordinance 2018-117 on September 20, 2018; and

**WHEREAS**, on March 6, 2019 the City Commission passed Ordinance 2019-103 to amend the budget to increase the General Fund \$1,691,982 and the Capital Improvement Program \$1,691,982; and

**WHEREAS**, the City Commission acknowledges that an additional amendment is required to the Annual Operating Budget for Fiscal Year 2018-2019, as designated in Exhibit “A”;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA:**

**SECTION 1.** Each and all of the foregoing “Whereas” clauses are true and correct and are incorporated herein.

**SECTION 2.** That the Annual Operating Budget, approved by the City Commission on September 20, 2018, is amended as designated in Exhibit “A” attached hereto.

**SECTION 3.** The City Commission hereby ratifies and confirms all other provisions of Ordinance 2018-117 and Ordinance 2019-103.

**SECTION 4.** Repeal of Conflicting Ordinances.

All prior ordinances or resolutions or part thereof in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 5.** Severability.

Should any part, term or provision of this Ordinance be by the courts decided to be invalid, illegal or in conflict with any law of this State, the validity of the remaining portions or provisions shall not be affected thereby.

**SECTION 6.** Effective Date.

This Ordinance shall become effective upon the approval of the City Commission.
