Vendor set-up begins at 5:30 p.m. and must be completed by 6:30 p.m.

Parade Route: Along Sample Road from Coral Springs Drive east to City Hall.

Booth Fee: a nominal \$75.00 for non-profit and \$150.00 for profit is required to secure location. *Please price your items affordably.*

Important: All booths and pushcarts must be removed from Sample Road when event has completed.

**Insurance: Food vendors shall furnish proof of Insurance indicating required liability and food service coverage**, to be attached to contract application.

**Set-Up:** Vendors are responsible for their own self-contained units, which comply with Health & Fire Regulations, Tents, Tables, Chairs, and any other items necessary. **No electric will be available for vendors!**

**Any use of propane would require you to contact the Fire Department for a permit.**
