Land Development Code

Section 1901. Improvements within public rights-of-way

(b) *Issuance of permit:*

(1) *Application for permit.* All persons, natural or corporate, desiring to perform any work within the public rights-of-way shall make written application to the city engineer, on forms provided by the city, requiring such information as the city deems necessary and proper to carry out the intent of this section.

- a. Each application for a permit must include a provision whereby the applicant agrees to indemnify and hold harmless the City of Coral Springs, all its officers, elected or otherwise, and its employees from any and all losses, claims or damages, (including attorney's fees and costs in any matter arising out of the negligence of the applicant, his agents or employees) to persons or property, presented in any manner, as a result of the applicant's work within the public right-of-way. Said agreement shall be part of the consideration required for the permitting of the entry onto and use of public lands.
